This Binder Resin (polymer) is regarded as registered because the monomers (>2%) are in EINECS. Carcinogens:it contains carbonblack listed by IARC as Group2B (possibility carcinogenic to humans); however, no significant exposure to carbonblack is thought to occur during the use of the product because carbonblack is in a boundform in it. It contains less than 1% of titanium dioxide listed as category2 for carcinogenicity and not classified in Table 1.1 of Annex VI to Regulation EC 1272/2008
